- The above Financial Results which are published in accordance with Regulation 33 of the Securities and Exchange Board of India (Listing Obligations & Disclosure Requirements), Regulations, 2015 have been reviewed and recommended by the Audit Committee and approved by the Board of Directors at their meeting held on May 12, 2026. The Financial Results are in accordance with the Indian Accounting Standards (Ind-AS) as prescribed under Section 133 of the Companies Act 2013 ("Act"), read with Rule 3 of the Companies (Indian Accounting Standards) Rules, 2015 (including any amendment(s)/modification(s) / re-enactment(s) thereto). The Financial Results have been subjected to audit by the Statutory Auditors of the Company, who have issued an Unmodified Opinion.
- The Company operates in only one business segment.
- Previous period's figures have been regrouped/rearranged to make them comparable with those of current period.
- The Board of Directors have recommended a Final Dividend of 15% (Previous Year 15%) of the Equity Share Capital of the Company, that is Rs. 1.5/- (Previous Year Rs. 1.5/-) per Equity Share of Face Value of Rs. 10/- each for the financial year ended March 31, 2026, subject to the approval of the Shareholders at the ensuing 46th Annual General Meeting of the Company.
- The above financial results has been approved by the Board of Directors and Audit Committee in their meeting held on 12 May 2026.
- The Figures for the Quarter ended on 31 March 2026 has been taken as the balancing figures of the full financial year and 9 months figures.
- A petition has been filed before the Hon'ble National Company Law Tribunal, Ahmedabad Bench ("NCLT") against the Company and certain promoters of the Company. Pursuant to the interim directions/orders passed by the Hon'ble NCLT in the said matter, the proceedings of the 43rd Annual General Meeting of the Company is presently kept in abeyance until further directions/orders of the Hon'ble Tribunal. Accordingly, the payment of the Final Dividend for year 2023-24 is also kept in abeyance till further orders.
- On 8th July 2024, a petition was filed before the Hon'ble National Company Law Tribunal, Ahmedabad Bench ("NCLT") under Sections 241 and 242 of the Companies Act, 2013, by (a) Mr. Sudip Patel, Director and Promoter, (b) Mrs. Rachana Patel, Promoter, and (c) Mr. Nilay Patel, Promoter, alleging oppression and mismanagement in the affairs of the Company.
- The matter is presently pending adjudication before the Hon'ble NCLT. The Company has denied the allegations made in the petition, including allegations relating to fraud and mismanagement, and is taking appropriate legal steps to defend its position in accordance with law. During the course of proceedings, the Hon'ble Tribunal has directed the parties to undergo mediation and has appointed a Mediator for facilitating resolution of the dispute. The Company is committed to extending full cooperation in the mediation proceedings and complying with the directions of the Hon'ble Tribunal."
